### 1. Rules:

- 1.1 The regatta will be governed by the Racing Rules of Sailing 2021-2024, the prescriptions of US Sailing, ISSA Procedural Rules, MISSA District rules, this Notice of Race, and the Sailing Instructions.
- 1.2 In the event of a conflict between the governing documents, the Sailing Instructions will take precedence.
- 1.3 The organizing authority is MISSA in conjunction with Culver Academies.

### 2. Qualification:

2.1 This event is a qualifier for the Great Lakes Championship, the Shepherd Championship, and the Atlantic Coast Championship. The first place team will earn a berth to both the Great Lakes Championship and the Atlantic Coast Championship. The second through fourth place teams will earn a berth to the Great Lakes Championship, and the fifth through eighth place teams will earn berths to the Shepherd Championship. Berths not accepted in accordance with MISSA Rule 5.10 will be reallocated by the MISSA District Director.

### 3. Eligibility:

- 3.1 Competing schools must be members of ISSA and meet ISSA eligibility rules as prescribed in Procedural Rules Part III.
- 3.2 Only MISSA Central district teams are eligible for this regatta.
- 3.3 All teams are required to have a designated on the water coach for safety and boat rotations.

# 4. Entry and Communications:

- 4.1 Teams can enter by paying the Entry Fee at the <u>Eventbrite</u> site by 1700 Eastern Time on Friday, October 1, 2021. All entries must be made through the site.
- 4.2 Each school may enter one team (1 A Division and 1 B Division) with or without alternates. Mix teams are not allowed. All competitors must be grade 9-12.

### Notice of Race

- 4.3 Each team must complete and Entry Form and waiver. The Entry Form must be completed and submitted before the end of registration on Saturday October 9. Incomplete or missing forms will result in the respective team/school being excluded from the regatta. Forms are to be emailed to joe.hanko@culver.org.
- 4.4 Entered teams unable to compete must notify the Regatta Chairperson and their MISSA representative as soon as possible. All entry fees are final and nonrefundable after 1700 Eastern Time on Friday, October 1, 2021. Registrations are not transferable between teams.

## 5. Entry Fee

- 5.1 The entry fee is \$200 per team, \$50 per additional sailor. This includes lunch Saturday and Sunday.
- 5.2 All entry fees must be submitted through **EventBrite**.

#### 6. Damage Deposits

6.1 A damage deposit of (\$250.00) **per boat** is required. The refundable boat damage deposit may be submitted via mail before the regatta, or in cash or check at regatta registration. Schools that fail to do so will not compete. The deposit is refundable provided all equipment and boats are returned undamaged. All boats will be inspected prior to and after sailing for preexisting and new damage. Any school that modifies, changes, or otherwise improperly rigs their boat's rigging, halyards, or other equipment and components, will be charged the necessary amount from their damage deposit to return the boat to its pre-race condition.

### 7. Housing

- 7.1 Woodcraft Camp Cabins will be available on a first-come, first-serve basis. They are for athletes and a coach/chaperon. They sleep 12 athletes plus the <u>required</u> adult chaperon in a separate single room. Multiple schools may share a cabin. Please make these arrangements between teams, then notify the Regatta Chair. <u>Please note</u>: the accommodations are quite utilitarian the cabins are unheated with separate bathroom buildings. There will be designated male/female cabins and bathrooms/showers. Bunk beds with mattresses are provided. Bathrooms <u>do</u> have hot water and showers. <u>You will need to supply your own pillows, bedding/sleeping bag, and towels</u>.
- 7.2 Cabins must be reserved by 1700 Eastern Time on Friday, October 1, 2021, by contacting the Regatta Chairperson once the school's *entry* and *registration fees*, have been submitted. Culver Academies cannot guarantee cabin availability until these have been submitted.
- 7.3 Check-in for housing will be between 1800-2100 Eastern Time on Friday, 8 October. Schools may also checkin to receive their cabin assignment during registration on Saturday morning from 0700-0800 Eastern Time.
- 7.4 Cabins will be inspected prior to check-out on Sunday at 1430 Eastern Time. Schools will be charged from their damage deposit if their respective cabin(s) are damaged or left excessively dirty.

#### 8. Boats

- 8.1 24 C 420s will be provided by Culver Academies. Boats will be sailed as provided. Competitors may bring telltales for shrouds.
- 8.2 Dock space is available for visiting team coach boats. A limited number of Whaler 17's may be available for visiting coaches.

#### 9. Regatta Format

- 9.1 This is a two-division (A and B) regatta. Boat rotations will occur per the rotation schedule in Techscore.
- 9.2 Rotations may take place from shore or coach boat as designated by the OA. To rotate from shore the incoming crew will meet the outgoing crew while the boat is afloat at the beach. A coach, chaperon, parent, or other support personnel affiliated with the school **must** be present to assist with rotations.

### 12. Awards

#### **13. Official Notice**

- 13.1 Losses and damages to borrowed equipment due to willful, wanton, negligent or careless handling of equipment shall be the responsibility of the school or team members. By submitting registration, the respective school agrees and guarantees reimbursement to the Culver Educational Foundation in the event of such loss or damage.
- 13.2 The Culver Academies campus is tobacco free, and any such use will result in immediate dismissal from the property of the offender by Campus Security.

#### 14. Rights to Use Name and Likeness

14.1 By participating in this event, competitors automatically grant to the Organizing Authority and the event sponsors the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

- 15.2 The race organizers (organizing authority, race committee, protest committee, host organization, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
