1. RULES:

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*, the <u>ISSA Procedural Rules</u> and the <u>ISSA National Championship General Conditions</u> and <u>the Scholastic Dinghy Class Rules</u>.
- 1.2. The Organizing Authority (OA) is the Interscholastic Sailing Association in conjunction with host Severn School & Georgetown University Sailing Team. The venue is Washington Sailing Marina, 1 Marina Drive, Alexandria, VA 22314
- 1.3. Appendix P, Special Procedures for Rule 42, as modified by ISSA Procedural Rule 14(c) will be in effect.
- **2. SAILING INSTRUCTIONS:** The sailing instructions will be posted on Tech Score prior to the report time for the regatta. This is a single-division regatta.
- **3. COMMUNICATION:** The online official notice board will be Tech Score.

4. ELIGIBILITY AND ENTRY

- 4.1. Competing schools and competitors must be members of ISSA and meet ISSA eligibility rules as prescribed in the Procedural Rules. Any open berths not filled by MASSA teams will be offered to eligible teams outside the MASSA district.
- 4.2. In the spirit of varsity competitive interscholastic competition, selection of competing schools will be by application/resume. The regatta has 20-24 berths. Allocations will be determined by the MASSA board. Schools should contact their coaches and/or league directors to find out details on any local qualifiers. Otherwise, registration is first-come, first served. Applications will be reviewed in the order they are received.
- **4.3.** Eligible schools and sailors must enter by submitting a resume using the following form. *Registration is now closed.*

8. RACING AREA: All races will be sailed out of Washington Sailing Marina, either in the basin or out in the river.

9. TRAVEL, VENUE, AND HOUSING:

- **9.1.** Competitors should use Reagan National Airport. Alternative airports are (BWI), and (IAD).
- 9.2. No Housing is provided.
- 9.3. Venue is the Washington Sailing Marina, 1 Marina Drive, Alexandria, VA, 22314. This is where the Georgetown University Sailing Team trains.

10. COACHING:

10.1. Team leaders, chaperones, coaches, parents, advisors and other support personnel shall not go afloat in the sailing area from the start of registration time on Friday until the end of the regatta unless explicitly permitted by the regatta chair. The penalty for failing to comply with this requirement may be the disqualification of all boats, competitors and teams associated with the infringing support personnel.

11. PRIZES:

- **11.1.** Prizes will be awarded to schools placing 1st, 2nd and 3rd in the regatta.
- **11.2.** n/a
- 12. RIGHTS TO USE NAME AND LIKENESS: By participating in this event, competitors automatically grant to the Organizing Authority and the event sponsors the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.
- **13. WAIVER OF LIABILITY:** Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race.

The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
