NOTICE OF RACE

1. RULES:

The regatta will be governed by the 2025-2028 ISAF RRS, and will be run in accordance with the Interscholastic Sailing Association Procedural Rules (unless modified by this NOR), MISSA District Rules, this Notice of Race and the Sailing Instructions. In accordance with RRS 70.5 (a), decisions of the protest committee are final. US Sailing's permission has been granted. This is a Tier 2 event.

2. ELIGIBILITY:

2.1 Competing high school teams must be members in good standing with MISSA and ISSA and located in the Southeast Region of MISSA.

2.2 A team of no fewer than 4 or more than 8 sailors who are full time students in the school they represent. Only one team per school.

2.3 MISSA Rule 10.5 is in effect. You MUST notify your acceptance to the next competition by the deadline, September 30, 2025 by noon CDT.

3: RACING AREA:

3.1. Races will be sailed on Hoover Reservoir, Westerville OH.

4: COACHING:

Coaching shall comply with ISSA PR 8. Coaches will not go afloat. All coaching will be done on the sunny banks or docks at Hoover Sailing Club

5: ENTRY FEE:

5.1 Each team must notify HSC (614/843-7325) of the number of sailors they expect to bring no later than Tuesday September 23, 2025 by 12pm (Noon) EDT.

5.2 The entry fee is \$50 per sailor. The fee includes breakfast and lunch Saturday and after racing snacks Saturday and Sunday. Checks should be made payable to "Hoover Sailing Club."

5.3 Each team shall be allowed one free lunch for their coach.

5.4 Additional meal plans for non-competitors may be purchased for \$20 and these requests should accompany that team's entry form.

6: BOATS:

E420s will be sailed as is. Boats will be checked in and out upon launch. Any previously existing damage should be reported upon launching. Any new damage should be reported between races to the boatswain on the rotation dock. All damage is the responsibility of the person(s) at fault.

7: SCHEDULE:

Saturday, September 27, 2025

0800- Check in and Registration

0800-0900- Rigging of boats

0900- Competitors meeting mandatory for all sailors

0945- First Warning, race 1. Races will continue throughout the day. Lunch will be served on shore between sets. Racing will not stop during the day.

1600- No race shall start after this time.

**** If a full rotation is complete by 4pm Saturday, no racing will occur on Sunday ****

Sunday September 28, 2025

0800- Check in and rigging of boats

0845- Competitors meeting mandatory for all sailors

0930- First Warning race 1 of the day.

1300- No race shall start after this time.

1400- Awards and departure

8. PRIZES:

8.1: Trophies will be awarded to the top 3 A and B division teams and the top 3 overall teams.

8.2: Championship qualifying: The top four (4) overall finishing schools will qualify for the MISSA Great Lakes Championships held at Chicago YC (Belmont Station) October 25-26, 2025. In addition, teams finishing 5th-8th will qualify for the Shepherd Championship held at Columbia YC October 25-26, 2025. Schools earning berths must confirm in accordance with MISSA District Rule 5.11.
