Notice of Race

1. Rules:

1.1. The regatta will be governed by the 2013-2016 ISAF Racing Rules of Sailing (RRS), the prescriptions of the United States Sailing Association, the Interscholastic Sailing Association Procedural Rules, this Notice of Race and the Sailing Instructions.

2. Eligibility:

2.1. Competing schools must be members in good standing of ISSA and meet ISSA eligibility rules as prescribed in the ISSA Procedural Rules. Membership will be verified prior to registration.

2.2. A "Team" is comprised in accordance with ISSA PR 1.2.

2.3. Each team must be accompanied by an adult adviser, parent or coach.

3. Entry:

3.1. This event is open to East area teams only.

3.2. Entry deadline is April 14, 2015. Coaches/Team leaders must email dgerber@bluewatersailandcanvas.com to register their team.

4. Entry fee:

4.1. The entry fee is \$40.00 per sailor. A continental breakfast and lunches are provided.

5. Boats:

5.1. Club 420's shall be sailed as provided.

5.2. No changes or modifications to rigging or boats are permitted without permission of the Regatta Chair. Teams violating this rule may be disqualified from the regatta.

6. Safety:

6.1. US Coast Guard approved Type III life jackets must be worn while on boats at all times.

6.2. Competitors are strongly encouraged to bring a dry-suit.

8. Racing Area:

8.1. Races sailed on Boardman Lake, Traverse City, MI

9. Courses:

9.1. Based on conditions, the Race Committee will determine the courses in accordance with ISSA Procedural Rules.

10. Scoring:

10.1. The regatta will be scored using ISSA Procedural Rules.

11. Protests:

11.1. Competitors protesting a boat shall comply with ISSA PR 16 notification (a) and (b) and RRS 61.1. Failure to do so may be grounds for closing the protest hearing under RRS 63.5.

11.2. A competitor shall not communicate with anyone other than teammates or other competitors before reporting to the RC an intension to file a protest. Breaking this rule may be grounds for closing the protest hearings. This changes RRS 61.

11.3. No appeals will be allowed in accordance with ISSA PR's, Part VI, Section 16, (f).

12. Coaching:

12.1. All coaches must be registered in accordance with MISSA By-Laws, Section 3 "Registration-Coaches."

12.2. Coaching shall comply with ISSA PR 8.

13. Prizes:

13.1. Trophies awarded to Top 3 teams.

13.2. Championship qualifying: The top six (6) overall finishing schools in FLEET racing qualify for MISSA Mallory Qualifier competition to be held April 25-26 at the Pewaukee YC-Milwaukee, WI. The 6 qualifying schools must confirm their intent to attend the event with the MISSA President within 48 hours of qualifying.

13.3. Championship qualifying: The top three (3) overall finishing schools in TEAM racing qualify for MISSA Baker Qualifier competition to be held May 16-17 at the Pontiac YC-Detroit, MI. The 3 qualifying schools must confirm their intent to attend the event with the MISSA President within 48 hours of qualifying.

14. Housing:

There is no housing provided for this event.
