



NOTICE OF RACE MISSA BAKER May 1 - 2

1. RULES:

- 1.1. The regatta will be governed by the rules as defined in:
 - 1.1.1. The Racing Rules of Sailing, including Appendix D, which applies in full.
 - 1.1.2. The Official Procedural Rules for Interscholastic Sailing Competition published by the Interscholastic Sailing Association ("ISSA") as modified by this NOR; and,
 - 1.1.3. The Midwest Interscholastic Sailing Association ("MISSA") Supplemental Rules.
- 1.2. The regatta has 10 berths. Selection of competing schools is determined by MISSA Supplemental Rule 5.5. Vacated berths may be reassigned at the discretion of the MISSA District Director.
- 1.3. ISSA Appendix 7 does not apply in any way. Actions in this section are completely replaced by RRS Appendix D, as modified by ISSA Procedural Rule 12.
- 1.4. Races will be umpired according to RRS D2.
- 1.5. In accordance with the US Sailing prescription to RRS 70.5 and ISSA PR 20, the right to appeal is denied for this event.

2. ELIGIBILITY:

- 2.1. This event is open to all MISSA member schools in good standing.
- 2.2. This is a Tier 1 regatta.
- 2.3. A team shall have no fewer than six sailors.

3. ENTRY AND COMMUNICATIONS:

- 3.1. Teams shall register online with their intention to compete by 17:00 CDT April 23rd https://hssailing.org/machform/view.php?id=46140
- 3.2. The online official notice board will be located under "Notice Board" on the MISSA Baker Qualifier page at http://scores.hssailing.org. The Sailing Instructions will be available on this notice board prior to the competitor's meeting.
- 3.3. The entry is \$20 per competitor.
- 3.4. Lunch will not be provided. All competitors and coaches must bring their own lunch

4. BOATS:

4.1. Club 420s will be provided by the Lake Minnetonka Sailing School. Boats will be sailed as provided.

6. RACING AREA:

6.1. All races will be sailed in close proximity to the Lake Minnetonka Sailing School (Lighthouse Island).

7. COURSES:

7.1. Based on conditions, the Race Committee will determine the courses as prescribed in ISSA Procedural Rule 7.8 and Appendix 6 (Digital N).

8. SCORING:

8.1. The regatta will be scored in accordance with ISSA Procedural Rules.

9. COACHING:

9.1. All coaching will be from shore unless explicitly permitted by the regatta chairperson.

10. VENUE SPECIFIC INSTRUCTIONS:

10.1. LMSS will shuttle sailors to and from Lighthouse Island via Park Avenue (19800 Park Ave. Deephaven, MN). There is parking on either side of the Deephaven Beach, but permits are REQUIRED to park there. Non-permit parking is available on the shoulder of Park Ave & Deephaven Ave (18990 Park Ave Wayzata). Additional non- permit parking can be found north on Lake Ave, Azure, and Rutledge.

11. RIGHTS TO USE NAME AND LIKENESS:

11.1. By participating in this event, competitors automatically grant to the Organizing Authority and the event sponsors the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

12. PRIZES

- 12.1. Prizes will be awarded to the top three teams
- 12.2. The top 2 teams will be granted invitations to the ISSA Baker Championship. Berths must be accepted in accordance with MISSA Rule 5.10 or they will be reassigned.

13. HOUSING

13.1. No housing will be available

14. WAIVER OF LIABILITY:

- 14.1. Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 3, Decision to Race.
- 14.2. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or

other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
