NOTICE OF RACE

## 1. Rules

- 1.1 The regatta will be governed by the rules as defined in the current Racing Rules of Sailing (RRS), the Prescriptions of US Sailing, the Inter-Scholastic Sailing Association (ISSA) Procedural Rules, MISSA Supplemental Rules, this Notice of Race, and the Sailing Instructions.
- 1.2 The Organizing Authority is the MISSA in conjunction with Lake Forest Sailing (LFS).
- 1.3 RRS Appendix P is in effect as modified by ISSA Procedural Rule 14(c).

# 2. Eligibility

- 2.1 Competitors must be attached to a school that is members of ISSA/MISSA and meet eligibility rules as prescribed in the ISSA Procedural Rules.
- 2.2 Competitors must be accompanied by a designated adult team leader, who may be an advisor, coach, or parent recognized by the school.
- 2.3 This is a Tier 1 event, competitors must be in 9,10,11 or 12<sup>th</sup> grade.

# 3. Registration and Entry Fee

- 3.1 The Entry Fee is \$50 per competitor payable during online registration via credit card. Entry fee includes a regatta take-home.
- 3.2 Eligible sailors must register by submitting an official online entry form at <a href="https://hssailing.org/machform/view.php?id=56934">https://hssailing.org/machform/view.php?id=56934</a>
- 3.3 The entry deadline is April 12<sup>th</sup>, 2021. A late fee of \$10 will be applied to any entries after April 12<sup>th</sup>. No entries will be accepted after April 22<sup>nd</sup> at 1700h CST.

## 4. Boats

- 4.1 Laser and ILCA boats & rigging are allowed at this event. Class legal sails are required, however generic spars may be used upon competitor request and OA inspection.
- 4.2 This is a bring your own boat event. No dollies will be provided and boats must be kept on dollies in the boat park.

## 5. Fleets

- 5.1 There will be Laser Full Rig (ILCA 7), Laser Radial (ILCA 6) and Laser 4.7(ILCA 4) fleets, each with their own start.
- 5.2 A minimum of 3 boats must be registered for each fleet

### 6. Schedule

Friday April 23

1600h-1800h – Boat drop off & optional practice (must have coach present to practice).

0830h-0930h – Competitor check-in at LFS office

### 7. Sailing Instructions

7.1 Sailing Instructions will be available online at the TechScore event page.

## 8. Racing Area

8.1 The racing area will be in the open waters of Lake Michigan off of Forest Park Beach.

## 9. Venue

- 9.1 All on shore venue locations are detailed in Attachment A
- 9.2 Parking rules must be followed and will be enforced. Center aisle is for cars with trailers attached only. Sailboats should not be staged in the parking lot unless actively being launched in to the basin.
- 9.3 No animals or pets are allowed at Forest Park Beach
- 9.4 Forest Park Beach is public space and all valuables should be properly stowed while out sailing.

## 10. Transportation & Housing

- 10.1 The best way to find the venue is to put "lake forest sailing" into google maps. Take Deerpath RD EAST. It will dead-end at Lake RD, go RIGHT/SOUTH on to Lake RD. This will bring you dowOn a hill, to the venue parking lot.
- 10.2 No housing will be provided. Attachment B details a list of lodging options in the area.

## 11. Coaching

- 11.1 Competitors may receive coaching, including instruction, assistance, equipment, or sustenance, only while in a designated coaching area as described in the Sailing Instructions.
- 11.2 Coach boats will not be provided. All competitors must have a designated coach on the water at all times, in a coach boat capable of handling Lake Michigan conditions.
- 11.3 Coaches must be registered properly with the competitors' school team with ISSA.

### 12. Photography Consent/ Drones

- 12.1 By entering this regatta competitors accept that they may be photographed and/or videotaped participating in the races and/or using the host's facilities and they consent to taking of such images and to the use, reuse, publication and republication of such images in any media, in conjunction with the competitors name or not, without compensation and without competitor approval of such images or any use thereof.
- 12.2 Drones for any use are not permitted at Forest Park Beach. Drones are not allowed to be flown for any purposes of this event. Violation of this rule may result in a penalty to competitor associated with. The Host/ OA may elect to use a certified drone pilot for media purposes.

### 13. Awards

- 13.1 Awards will be given to first, second, and third place finishers in each fleet
- 13.2 The coaches will come together after racing on Sunday to decide on a competitor to receive the event's Sportsmanship Award.

## 14. Official Notice

14.1 No contestant shall use, either on or off the water, marijuana or any other controlled substance, as defined in 21 U.S Code 802, the possession of which is unlawful under U.S Code 841, or alcoholic beverages (distilled spirits, wine, and beer, each as defined in Chapter 51 of the U.S. Internal Revenue Code and intended for beverage use). An alleged breach of this procedural rule shall not be grounds for a protest. However, when a report is received from any source, alleging such a breach a protest committee consisting of the regatta chairperson, a member of the MISSA Board of Directors, and the chairperson of the Protest Committee, shall follow the process described in RRS 69.1(b). If a hearing under RRS 69 is held, a competitor found to have breached this procedural rule shall be excluded from the remaining races of the series and, where practical, be removed from the regatta venues and sent home. Additional penalties consistent with RRS 69.2 may be imposed on the competitor. This regulation is in effect during the entire event from the date and time of arrival through the date and time of departure from the regatta site.

#### 15. Waiver of Liability

15.1 Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 3 and 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host, sponsors, or any other organization official) will not be responsible for damage to any boat or other property

or the injury to any competitor, including death, sustained as a result of participation in this evet. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

From <u>route 41</u> take the Deer Path Rd. exit and go East towards downtown LF. Sta on Deer Path until it dead-ends at Lake Rd. Go *right* on Lake Rd and follow it down the South access road hill to the LFS parking lot.
