## **NOTICE OF RACE**

## 1. RULES:

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*, the <u>ISSA Procedural Rules</u>, and <u>the Scholastic Dinghy Class Rules</u>, the MASSA Supplemental Rules, the MASSA Code of Conduct, this NOR, and the Sailing Instructions. In the event of a conflict between the governing documents and the Sailing Instructions, the latter shall take precedence.
- 1.2. The Organizing Authority (OA) is the MidAtlantic Scholastic Sailing Association in conjunction with the host, the Virginia Interscholastic Sailing Association and Youth Sailing Virginia.
- 1.3. In accordance with RRS 70.5(a) decisions of the protest committee are final, US Sailing permission has been granted.
- 1.4. Appendix P, Special Procedures for Rule 42, as modified by ISSA Procedural Rule 14(c) will be in effect.
- **2. SAILING INSTRUCTIONS:** The sailing instructions will be posted on Tech Score prior to the report time for the regatta.
- **3. COMMUNICATION:** The online official notice board will be Tech Score.

#### 4. ELIGIBILITY AND ENTRY:

- 4.1. Competing schools and competitors must be members of ISSA and meet ISSA eligibility rules as prescribed in the Procedural Rules.
- 4.2. Selection of competing schools will be by district elimination. The regatta has 18 two division berths. Allocations will be as follows: MASSA (6), MISSA (4) and NESSA (4). There are 4 open at-large berths that will be filled by application. Schools should contact their district directors to find out details regarding allocations for MASSA, NESSA, and MISSA.
- 4.3. Teams wishing to apply for the at-large berths should contact Randall Nunn; and submit in writing the intent to do so including a team resume. Effort will be given to include teams from other ISSA districts, but performance within your district will be criteria for selection.
- 4.3. Eligible schools and sailors who have been offered a berth must enter by registering with the MASSA Director on the google form by **May 23, 2022.** If the elimination for your league is to be held after this date, please have the district director contact the MASSA Director immediately so arrangements can be made

- 4.4. Teams unable to compete must notify the MASSA Director as soon as possible.
- 4.5. MASSA will reallocate vacant district quotas. The first open allocation will go to the host league. A berth becomes vacant when the qualifying league becomes unable to fill the berth.

## 5. FEES:

- 5.1. The entry is \$200.00 per team. This includes Saturday's competitor function and lunch.
- 1.1. Upon acceptance of entry, teams will be invoiced by MASSA, and will then pay MASSA by credit card.
- 6. BOATS: 18 collegiate rigged FJ dinghies will be provided by the host. Boats will be sailed as provided.

8. RACING AREA: All races will be sailed Mill Creek in front of the Sailing Center and the Community Center.

## 9. COACHING:

- 9.1 All Coaching Shall be done from the floating dock unless otherwise instructed. The penalty for any coaching done outside these parameters shall be disqualification of all boats for the nearest race in time.
- 9.2. Once a team has qualified for the event, members of that team shall not sail at the site to be used for the event, unless that site is their School's home waters or there is a previously scheduled MASSA or VISA regatta. Violation of this condition may be cause for disqualification of the team from the event.

# 11. PRIZES:

- 11.1. Prizes will be awarded to schools placing 1st, 2nd and 3rd in the regatta.
- **12. RIGHTS TO USE NAME AND LIKENESS:** By participating in this event, competitors automatically grant to the Organizing Authority and the event sponsors the right, in perpetuity, to make, use and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.
- 13. WAIVER OF LIABILITY: Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
