## SAILING INSTRUCTIONS

## 1. RULES:

Team Racing Rules, the ISSA Procedural Rules, the Scholastic Dinghy Class Rules, and the ISSA National Championship General Conditions.

## 2. NOTICE TO COMPETITORS:

- **2.1.** Official notices will be posted on the official notice board located on Tech Score.
- **2.2.** Changes to the sailing instructions shall be approved by the protest committee and the ISSA representative and posted no later than one half hour prior to the first warning signal on the day it will take effect.
- **3. CODE OF CONDUCT**: Competitors and support persons shall comply with reasonable requests from race officials.

### 4. SCHEDULE AND FORMAT:

- **4.1.** Report times each day are listed in the NOR.
- **4.2.** The number of races each day will be at the discretion of the regatta chair.
- **4.3.** Rotation schedules and boat assignments will be posted on Tech Score after the skipper's meeting.
- **4.4.** The format shall be a single round robin followed by a championship double round robin for the top four schools and a single round robin for silver (schools 5-8) and bronze (schools 9-12).
- **4.5.** In accordance with RRS D4.3(c), results from previous round robin stages shall carry forward.
- **4.6.** All tie breaking sails offs for gold, silver, and bronze rounds, must be completed before the final day of competition.

#### 5. COURSES AND MARKS:

- 5.1. Courses will be in accordance with ISSA PR Appendix 6 (Digital N Course)
- **5.2.** Course marks will be small red balls.
- 5.3. Start and Finish Pin marks will be medium red balls

### 6. START/FINISH AND SIGNALS:

- 6.1. Races will start in accordance with ISSA PR 7.9.
- **6.2.** ISSA PR 7.9(c) shall not apply.
- **6.3.** The start and finish lines will be between a flag on the race committee boat(s) and the course side of a nearby mark.

#### 7. BREAKDOWNS:

**7.1.** Breakdown requests shall be made in accordance with D5.2

**7.1.** Breakdowns shall be scored in accordance with ISSA PR 12.2. Compensation shall be consistent with ISSA PR Appendix 3.

#### 8. PROTESTS:

- **8.1.** Protests procedure will be in accordance with Appendix D2.
- **8.2.** In accordance with D2.2, a boat that protests is not entitled to a hearing. This statement overrides that conflict with ISSA PR Appendix 7
- 9. SCORING: Scoring will be in accordance with ISSA PR 12.
- **10. SAFETY:** A boat that retires from a race shall notify the race committee either before leaving the course, or if that is impossible, immediately after arriving ashore.
