SAILING INSTRUCTIONS

1. RULES:

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*, the <u>ISSA Procedural</u> <u>Rules</u> and <u>the Scholastic Dinghy Class Rules</u>.
- 1.2. The Organizing Authority (OA) is the NJISA in conjunction with TRYC and BBYRA.
- 1.3. Appendix P, Special Procedures for Rule 42, as modified by ISSA Procedural Rule 14(c) will be in effect.
- 1.4. In accordance with RRS 70.5(a) decisions of the protest committee are final, and US Sailing permission has been granted.

2. NOTICE TO COMPETITORS:

- **2.1.** Official notices will be posted on the official notice board located on Tech Scor and the white board located on the front patio of the club.
- **2.2.** Changes to the sailing instructions shall be approved by the protest committee and the ISSA Representative and posted no later than one half hour prior to the first warning signal on the day it will take effect.
- 3. **CODE OF CONDUCT**: Competitors and support persons shall comply with reasonable request from race officials per the MASSA Code of Conduct

4. SCHEDULE:

- 4.1. Report times each day are listed in the NOR.
- 4.2. The number of races each day will be at the discretion of the regatta chair.
- 4.3. Rotation schedules and boat assignments will be posted on Tech Score.

5. COURSES AND MARKS:

- 5.1. Courses will be in accordance with ISSA PR 7.8
- 5.2. The race committee may designate course selection orally.
- 5.3. All marks will be orange, round inflatable buoys.

6. START/FINISH AND SIGNALS:

- 6.1. Races will start in accordance with ISSA PR 7.9.
- 6.2. The start/finish line will be between a flag on the race committee boat and a mark.
- 6.3. X-Flag will be used for individual recalls

7. BREAKDOWNS:

- 7.1. Breakdown requests shall be filed in the same manner as protests.
- 7.2. Breakdowns shall be scored in accordance with ISSA PR 9(e). Compensation shall be consistent with ISSA PR Appendix 3.
- 8. PROTESTS: Protests procedure will be in accordance with ISSA PR Part VI
- 9. **SCORING:** Scoring will be in accordance with ISSA PR 9 and posted in TechScore.
- 10. **SAFETY:** A boat that retires from a race shall notify the race committee either before leaving the course, or if that is impossible, immediately after arriving ashore.
