

NWISA Gold Ranking Regatta #2 March 16-17, 2024 301 Shannon Drive SE Bainbridge Island, WA



SAILING INSTRUCTIONS

1. RULES:

- 1.1 The regatta will be governed by the Racing Rules of Sailing for 2021-2024, the prescriptions of US SAILING, the ISSA Procedural Rules, the NWISA District Rules, the Notice of Race, and the Sailing Instructions.
- 1.2 Under rule 70.5(a), the right of appeal is denied.
- 1.3 Appendix P, Special Procedures for Rule 42, as modified by ISSA Procedural Rule 14(c) will be in effect. Judges will enforce RRS 42 (two-turns penalty).
- 1.4 FJ class rules will not apply.

2. NOTICES TO COMPETITORS

- 2.1 Official notices will be posted on the official notice board located on TechScore.
- 2.2 Changes to the sailing instructions shall be posted no later than one half hour prior to the first warning signal on the day it will take effect.

3. SIGNALS MADE ASHORE

3.1 Signals made ashore shall be communicated verbally from the race committee boat at the dock.

4. THE START

- 4.1 The start line will be between a staff on the race committee boat displaying an orange flag and an orange buoy located to port.
- 4.3 Races will start in accordance with ISSA PR 7.9(a).
- 4.3 Individual recalls will be made in accordance with RRS Appendix U4.
- 4.4. In accordance with ISSA PR 7.9(c), general recalls will be signaled by a series of short whistles. After a general recall, the round-the-ends provision of RRS 30.1 shall automatically apply. The I-Flag need not be displayed (Changes RRS 30.1).

5. COURSE AND MARKS

5.1 The race committee will announce the course verbally prior to the warning signal and will display the course W1 or W2 on a course board.

6. THE FINISH

- 6.1 The finish line will be the same as the starting line (changes RRS *Race Signals*).
- 6.2 After finishing the final race of a set, competitors shall sail directly to the rotation

dock to switch pairs.

7. PROTESTS

- 7.1 Protest procedure and time limit will be in accordance with ISSA PR Part VI.
- 7.2 Protest forms will be available on the rotation dock during racing and at the wooden kiosk near the public boat ramp after racing is completed for the day.
- 7.3 Protest hearings will be held in the vicinity of the city dock and boat ramp.

8. SCORING

- 8.1 The regatta will be scored in accordance with ISSA Procedural Rule 9.
- 8.2 Teams failing to enter Record of Participation (RP) information on TechScore by the end of the protest time limit on Sunday shall be assessed an automatic penalty in accordance with PR 4.3(a).

9. BREAKDOWNS

- 9.1 Breakdown requests shall be filed in the same manner as protests.
- 9.2 Breakdowns shall be scored in accordance with ISSA PR 9(e). Compensation shall be consistent with the guidelines listed in ISSA PR Appendix 3.


10. SAFETY

- 10.1 Competitors shall wear a USCG-approved PFD per ISSA PR 2.2.
- 10.2 Swimming is not permitted near the marina docks.
- 10.3 A boat that retires from a race shall notify the race committee either before leaving the course, or if that is impossible, immediately after arriving at the rotation docks or at the Winslow public dock (end of day).
