1. RULES:

- 1.1. The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*, the <u>ISSA Procedural Rules</u> and the <u>the Scholastic Dinghy Class Rules</u>.
- 1.2. The Organizing Authority (OA) is the MDISA in conjunction with host Severn School. The venue is Magothy Marina.
- 1.3. Appendix P, Special Procedures for Rule 42, as modified by ISSA Procedural Rule 14(c) may be in effect.
- **2. SAILING INSTRUCTIONS:** The sailing instructions will be posted on Tech Score prior to the report time for the regatta. This is a 2-division event.
- 3. **COMMUNICATION:** The online official notice boards will be on shore at our shed, and on Tech Score.

4. ELIGIBILITY AND ENTRY

- 4.1. Competing schools and competitors must be members of ISSA and meet ISSA eligibility rules as prescribed in the Procedural Rules.

7. SCHEDULE:

Sunday, 07 April

0900-Report Time 1000-First Warning and schedule for the day 1500-No race will start after this time Changes to the schedule will be posted on Techscore and/or on a notice board at our team shed.

8. RACING AREA: All races will be sailed out of Magothy Marina.

9. TRAVEL, VENUE, and SPECIAL CONDITIONS:

The Magothy Marina is a private, condominium venue and restricts both parking and spectator access as they see fit. The following access/attendance restrictions are therefore in place, and failure to conform can result in team disqualification:

• Each team may only <u>park 1 vehicle (no exceptions)</u> in the back lot. To that end, parking passes will distributed on Sunday morning, and must be displayed on the front dash. There is a public parking lot at Jones Station Road/Severna Park Park 'n' Ride. There is absolutely NO parking on the street anywhere near the Magothy Marina.

- Spectating is limited to coach and players only.
- There is absolutely NO access beyond the "white line" on the gas dock for any spectator/player/coach.
- There is no gear storage available in the bathrooms.

10. COACHING:

10.1. Team leaders, chaperones, coaches, parents, advisors and other support personnel shall not go afloat in the sailing area from the start of registration time on Friday until the end of the regatta unless explicitly permitted by the regatta chair. The penalty for failing to comply with this requirement may be the disqualification of all boats, competitors and teams associated with the infringing support personnel.

11. PRIZES:

The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
