Notice of Race (NOR)

1 RULES

- 1.1 The event is governed by the Racing Rules of Sailing 2025-2028, the prescriptions of US Sailing, the rules as defined by MSS Regatta Regulations, this Notice of Race, and the Sailing Instructions.
- 1.2 The organizing authority (OA) is MSS in conjunction with LMSS.
- 1.3 In the event of a conflict between the governing documents, the Sailing Instructions will take precedence.

2 SAILING INSTRUCTIONS

2.1 The sailing instructions will be available on techscore (<u>scores.hssailing.org</u>) by 0800 on May 10th, 2025.

- 3.2 On the water, the race committee will make courtesy broadcasts to competitors & coaches on VHF radio channel 73.

4 ELIGIBILITY AND ENTRY

4.1 This event is open to Minnesota and Wisconsin based scholastic sailors and teams in good standing.

- 4.2 An entry consists of a "true" team of 6-9 sailors from a single MISSA School, or a "mixed" team of 6-9 sailors from 2 or more separate MISSA Schools.
- 4.3 This event is open to sailors in $7^{th} 12^{th}$ grade.
- 4.4 To be considered an entry in the event, each team shall complete all online registration forms and pay all by 0915 on May 10th, 2025. - 4.5 The following restrictions on the number of boats apply: a maximum of 8 teams.

5 FEES & DAMAGE DEPOSIT

- 5.1 Entry fees are \$50 per sailor, which shall be submitted online at the link listed in 4.4. Entry fees shall include Jimmy Johns lunch on Saturday, a light bagel/fruit breakfast on Sunday, and a regatta tech shirt.
- 5.2 Damage deposits are not required for this event.

7 COURSES & RACING AREA

- 7.1 Courses will be set and sailed in accordance with the recommendations set forth in the ISSA Procedural Rules 2025-2028. Any changes will be noted in the Sailing Instructions.
- 7.2 Races will be sailed in the vicinity of Lighthouse Island on Lake Minnetonka.

8 SCORING

8.1 RRS Appendix D shall be used for scoring, as modified in PR section 12.

9 COACHING

- 9.1 Support vessels shall keep clear of the racecourse and only coach between races.
- 9.2 Coaches may use LMSS coach boats.
- 9.3 Coaches shall, when necessary, umpire the races in which their sailors are competing.

10 BOATS

- 10.1 LMSS will provide 18 C420s.
- 10.2 Boats shall be sailed as provided.

11 RIGHTS TO USE NAME AND LIKENESS

11.1 By participating in this event, competitors automatically grant to the Organizing Authority the right, in perpetuity, to make, use and show, at their discretion, any photography, audio, and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

12 PHOTOGRAPHY, CAMERAS AND ELECTRONIC EQUIPMENT

12.1 Individuals and their teams are permitted to use personal video/film/camera or sound recording equipment on their boats, however, the video and audio obtained by their personal cameras may not be used during a protest hearing. Video/film/camera equipment includes, but is not limited to, GoPro and other action cameras, U.A.V.s, and Drones.

13 RISK STATEMENT & WAIVER OF LIABILITY

13.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

13.2 The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

14.1 There will be no awards given out at this event.

15.2 PARKING & SHUTTLES
