Notice of Race

- 1.1. The regatta will be governed by the Racing Rules of Sailing (RRS)2025-2028, and, ISSA Procedural Rules and MISSA Supplemental Rules.
- 1.2. In accordance with US Sailing prescription to RRS 70.3(b), there shall be no appeal of the decision of a protest or request for redress. US Sailing's permission has been granted.

2. Eligibility:

- 2.1. Competing schools must be members in good standing in MISSA Northeast.
- 2.2. This is a MISSA Tier 2 Regatta, sailors must be 9-12 grade, no mixed teams.
- 2.3. Only 1 team per school may register for each event.

3. Entry:

- 3.1. Entry deadline is April 4, 5PM EST. Coaches/Team leaders must email regatta chair with roster.
- 3.2. The maximum number of sailors per team that may register for this event is 8 sailors.

4. Entry fee:

4.1. The entry fee is \$60. Lunch will be provided and for one coach per team. A payment link will be provided after registration.

5. Boats:

- 5.1. Club 420s shall be sailed as provided.
- 5.2. No changes or modifications to rigging or boats are permitted

without permission of the Regatta Chair. Teams violating this rule may be disqualified from the regatta.

6. Safety:

- 6.1. Personal Floatation Devices must be worn in accordance with ISSA Procedural Rule 2.2.
- 6.2 Boat drivers- Kill cords shall be attached at all times while the engine is running. All who go afloat, must have a proper PFD worn correctly.

7. Schedule:

Launch. Racing will continue through the day. Racing will continue Sunday am. Modification is possible due to weather.

9 am continue Mallory.

No race after 3pm unless to compete a set.

8. Racing Area:

- 8.1. Races will be sailed on Cass Lake.
- 8.2. Bosun will be notified of any damage to the boats and must be notified immediately upon finishing the race. Bosun will be stationed near the finish.

9. Course:

9.1. Based on conditions, the Race Committee will determine the course in accordance with ISSA Procedural Rules.

10. Scoring:

10.1. The regatta will be scored using ISSA Procedural Rules.

11. Protests:

- 11.1. Competitors protesting a boat shall comply with ISSA PR 16 notification (a) and (b) and RRS 61.1. Failure to do so may be grounds for closing the protest hearing under RRS 63.5.
- 11.2. A competitor shall not communicate with anyone other than teammates or other competitors before reporting to the RC an intension to file a protest. Breaking this rule may be grounds for closing the protest hearings. This changes RRS 61.

12. Coaching:

- 12.1. All coaching will take place on shore or in area behind the start line on the water.
- 12.2. Coach boats are your responsibility to bring or make arraignments with another coach.
- 12.3. One coach on the water per team.

13. Prizes:

- 13.1. Awards to Top 3 teams
- 13.2. This event is a qualifier for the MISSA Mallory Qualifier, May 3-4, Chicago, Columbia Yacht Club. The number of berths available is 5. Berths will be allocated in accordance with MISSA Supplemental Rule 5.5 and must be accepted in accordance with MISSA Supplemental Rule 5.9.
