# **NOTICE OF RACE**

### 1. RULES

- 1.1. The regatta will be governed by the *rules* as defined in the Racing Rules of Sailing, including the ISSA Procedural Rules.
- 1.2. In accordance with RRS 70.3(b), decisions of the protest committee are final. US SAILING's permission has been granted.

# 2. SAILING INSTRUCTIONS

#### 4. ELIGIBILITY AND ENTRY

- 4.1. The regatta is open to NESSA and non-NESSA teams (conglomerate teams or out of district school teams).
- 4.2. Competitors must be accompanied by a designated adult chaperone, who may be an advisor, coach, or parent.
- 4.3. A maximum of 15 visiting teams will be accepted on a first come first serve basis.
- 4.4. Each team shall consist of at least four sailors, two skippers and two crews, all of whom shall be female.
- 4.5. Schools may enter multiple teams. However if the event is oversubscribed, all schools will be allowed one team before a second team from a school will be accepted.
- 4.6. Eligible teams can enter by completing the online entry form beginning April 7<sup>th</sup> at 0900, but no later than April 21<sup>st</sup>, 2025. Entry Form: <a href="https://forms.gle/o9kq2gPiQtGXP7ddA">https://forms.gle/o9kq2gPiQtGXP7ddA</a>
